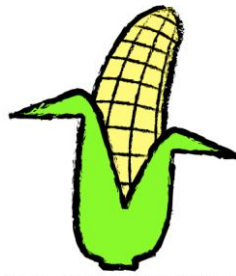
The purpose of this letter is to protest a judicial decision of January 16th, 2022, issued by the Federal Court of Australia made up of the federal judges Mr. James Allsop AO, Mr. Anthony Besanko, and Mr. David O'Callaghan.

We are puzzled by the law related to the immigrant application in the case of Mr. Novak Djokovic (Migration Act 1958, Section 133C(3)). While using his discrete rights to be the "Lord of the Australian Borders" Mr. Hawke, has accused Mr. Djokovic:

- (1) Of anti-vaxxer attitudes, (Not anti-vaxxer political or movement stands but relying on the arbitrary connotation of the term "attitude"),
- (2) Of being a threat to health and the good order grounds,
- (3) Of being a threat to public order and peace in Australia,
- (4) Of being in the public interest of Australia to have Mr. Djokovic deported.

During the court proceedings, Australian Federal Lawyer Mr. Stephen Lloyd has stated that Mr. Djokovic:

- (1) Was against vaccination even before vaccines were available and assumed that he is still against vaccination.
 - Oddly enough, he has not presented any facts proving where and when Mr. Djokovic made an anti-vaxxer stand before or after the introduction of Covid-19 vaccines. Are there any facts to support this vague and quite arbitrary statement?
- (2) Could have been vaccinated but failed to be vaccinated.
 - Mr. Djokovic was cleared not to be vaccinated before traveling to Melbourne. Privately opting not to subject himself to any personally undesired medical treatment does not make Mr. Djokovic a public activist or political promoter of the anti-vaxxer movement. Without evidence, Mr. Djokovic cannot be classified as a member of the anti-vaxxer movement! On the contrary, Mr. Djokovic has donated vast amounts of money for vaccines gifted to countries and communities that could not afford vaccines.
- (3) Being temporarily present in Australia encourages those who have not been vaccinated or partly vaccinated to take anti-vaxxer positions.
 - During the temporary stay in Melbourne, during just a few weeks, it is impossible for any sportsman to significantly influence Australian public opinion. On the contrary, by unreasonably abusing this fine young person of exemplary morals, his public profile has been enhanced.
- (4) Coming from Serbia, where less than half of the population has been vaccinated proves his anti-vaxxer political stand.

- Small, globally not quite significant state that is economically stranded has exercised more than a miraculous effort to achieve Covid-19 pandemic situation much better than we may find in Australia.

For the record, at the time of the above-mentioned court verdict, Australia has:

- (1) Approximately 25,600,000 citizens,
- (2) Vaccinated with dose 3 – 4,860,000 citizens,
- (3) Vaccinated with dose 2 protected under the 6 months rule – 6,080,000 citizens,
- (4) Vaccinated with dose 1 protected under the 6 months rule – 447,000 citizens,
- (5) Vaccinated with dose 1, however with the expired immunization – 403,000 citizens,
- (6) Vaccinated with dose 2, however with the expired immunization – 9,070,000 citizens.

In summary, we have the following situation:

1. 45,783,000 jabs were administered,
2. The percentage of the vaccinated Australian population is 81.20%
3. The percentage of the non-vaccinated population is 18.8%
4. The efficiency rate (The number of protected citizens vs. the number of jabs) is 24.87%

Surprisingly enough, in the state of Serbia we have the following data:

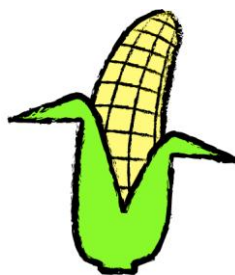
1. Number of citizens - 6,945,147
2. Total jabs administered - 7,951,760
3. Still immunized - 2,829,416
4. The efficiency rate (The number of protected citizens vs. the number of jabs) is 35.58%

In addition, we must keep in mind that the government of Australia reports odd data:

1. 183,994 or 29% were infected in the period from Jan 25, 2020, till Jan 31, 2022.
2. 439,991 or 71% of the infected in the unbelievably short period from Jan 1, 2022, till Jan 15, 2022.

We may ask ourselves, “Who is being better protected, citizens of Serbia or citizens of Australia? Is Mr. Djokovic a greater threat to Australia or is it, maybe Australia greater health threat to Mr. Djokovic?”

Since 18.8% of Australians were not vaccinated, and 9,070,000 vaccinated have expired immunization, Mr. Hawke should be aware that Mr. Djokovic could not possibly cause deterioration of this horrendous health situation in Australia? Was Mr. Hawke aware that Covid-19 vaccination does not imply Covid-19 immunity? Mr. Albert Burla CEO of Pfizer in the interview for Bloomberg Markets and Finance on January 13th, 2022, has explicitly said that after recovering from Covid-19, a person gains significant immunity against the recurring infection. This statement of Mr. Burla proves further that Mr. Djokovic is not as dangerous for the health situation in Australia as Mr. Hawke and Mr. Lloyd are presenting.

As chief designer of Mr. Djokovic “Melbourne Golghota,” Mr. Hawke, has even failed to take into account the World Health Organization Policy brief of April 13, 2021, which under “Covid-19 and mandatory vaccination: Ethical consideration and caveats,” has maintained that Covid-19 vaccination is not mandatory but is recommended. Australian government officials do not care for WHO recommendations and guidelines.

Mr. Djokovic left Melbourne while well-coordinated Australian media has launched a tsunami of anti-Djokovic propaganda. Currently, we witness in Australian media an avalanche of fault language aimed at Mr. Djokovic, aimed at a person of highest work and moral standards, four years voted the best sportsman in the world.

We, members of the association “Srpski Krivak,” take the firm position that convicting a person of proven moral qualities based on the insinuations, allegations, and rumors, trying to build circumstantial evidence, is simply not to be expected from a dignified court or from a decent person that Mr. Hawke may not be.
